Breeding decreased due to less demand. Now approx 15 matings per month compared to 30 of recent times.

Customers now being advised that rather than breed to expected demand(which is not predictable at this time) MBR Acres are working on a first come first served basis.

No Marshall's bitches brought in yet, as demand not there and the existing RCC colony is naturally running down in terms of numbers due to decreased demand.

At time of visit there were: 21 stud males, 188 breeding females, (+7 in reserve), 452 stock males, 452 stock females, 74 suckling female young, 74 suckling male young.
